KF - Hvad er vi?

- Præsentation af klubberne og forskellige aktiviteter

Ændring i lønstruktur – Afstemning

- Problemet lige nu er, at folk ikke får nok i løn.
- **Fordele ved at være frivillig:**
 - Fordele blev ikke uddybet.
- **Hatten:**
 - Vi har en god leverandørforbindelse lige nu, som sikrer, at vi køber de rigtige varer.
 - En person nævnte, at det ikke er fair at hæve lønnen for meget.
 - Det blev bemærket, at de, der arbejder på Hatten, ikke kun gør det for penge, men også for at få stedet til at fungere.
 - Vi har et ansvar for at sikre, at Hatten fortsætter for fremtidige generationer.
 - Hvordan fungerer frivilligsystemet i Hatten?
 - **Frivillige:** Det er svært at fastholde frivillige, og det kan være udfordrende at få dem til at møde op til vagter. Frivillige kan dog have det sjovt under deres vagter.
 - **Bartendere:** Vil tjene 120 kr.
 - **Nattevagter:** 140 kr. Der skal være en ædru ansvarlig under Hattens åbningstider.

LLO - Afstemning

- Vi opfordrer folk til at gennemgå det.
- **Hvor mange bruger det?**
 - 8 personer har brugt det inden for det sidste år.
 - Vi hjalp 5 personer med det.
- **Lejernes Retshjælp** er et gratis alternativ.
 - Hvis man ved, at man flytter om 6 måneder, kan man selv blive medlem 6 måneder før.
- KF bør informere folk om gratis alternativer.
- Administrationen er meget venlige overfor nye beboere.
- Dette er en luksus, som ingen andre kollegier har, så det giver ikke mening at betale så meget for det.
- Det er chokerende, hvor meget vi betaler – det udgør næsten en tredjedel af vores budget.
- Forslag om at oprette en fond til dem, der har brug for hjælp med fraflytning.

- **KF:** Sociale aktiviteter
- **BR:** Ansvarlige for kontakten med administrationen og repræsenterer beboerne.
- Vi ønsker at samarbejde meget mere.

- Forslag om flere mesterskaber, især inden for sport – med præmier.
- Input fra BR: Idéen om at oprette arbejdsgrupper med fokus på specifikke emner.
- Forslag om at få beer pong-bordet tilbage.

Præsentation af regnskaber for perioden

Præsentation af Hattens regnskaber for perioden

- De ændrede priser, hvor meget påvirker de budgettet?
 - Vi brugte alt, hvad vi kunne, for at få Hatten tilbage til, hvad den var før.
 - De fleste udgifter fra juni og juli vil blive medtaget i næste semesters budget.
- **Udgifter:**
 - Det meste går til lagerbeholdning.
- **Udstyr:**
 - Det meste kommer fra nødvendige indkøb til Hattens renovering.
- **Administrativt:**
 - G4S var et problem med et tidligere KF-medlem, men vi er endelig kommet af med det.
 - Musiksystem – Spotify og KODA.

 - Der er plads i budgettet til at betale for mad til dem, der arbejder her. De fleste har brug for at spise på et tidspunkt, da deres vagter er lange.

General Assembly Minutes

Formalities

- Conductor – Emil Midjord Christensen
- Minute taker – Anders Balle
- Approval of the agenda – approved by everyone.

KF – Who are we?

- Represents the clubs and various activities.

Change in pay structure – Vote

- The issue right now is that people are not being paid enough.
- Benefits of being a volunteer:
 - Might x (information missing in the original minutes).
- **Hatten:**
 - We have a good supply connection right now to ensure that most of the things we buy are in order.
 - A participant pointed out that the pay increase is not at a fair rate.
 - Argument: The people working at Hatten are not doing it only for the money but to keep the place running.
 - We have a responsibility to keep the place running for future generations.
 - **How does the volunteer system work at Hatten?**
 - Volunteers?
 - It's difficult to ensure volunteers actually show up for their shifts, but they can have fun during shifts.
 - Bartenders: Earn 120 DKK.
 - Night shift managers: Earn 140 DKK. There needs to be a sober person during Hatten's opening hours due to alcohol licensing.
 - The new structure would also make it possible to attract more volunteers.
- **Ceramics club:** Depends on classes.
- **Yoga:** Works between 18-24 hours. Prices in the bar will not be affected if the vote doesn't go through. **Incentive for getting volunteers:** Vote: Everyone voted in favor.

LLO – Vote

- We encourage people to look into it.
- How many have used it?
 - 8 people have used it in the last year.
 - We directed 5 people to them.
 - **Lejernes Retshjælp** – a free alternative.
 - If you know you will be moving out in 6 months, you might as well become a member 6 months prior to moving out. KF should inform people about free

alternatives. The administration is very kind to new residents. We should still keep LLO but be more transparent about it.

This is a luxury that no other dormitories have, so it doesn't make sense to pay this much for it. It's shocking how much we pay – it's almost a third of our entire budget. An idea is to set up a fund for people who might need help with moving out.

Why is KF responsible for LLO?

- Because KF was the only one able to push it through.
- Former KF members were the ones who made it happen. Vote: Everyone voted for, except 2 people.

Collaboration between KF and BR

- KF: Social activities.
- BR: Responsible for being in contact with the administration and representing the residents. We want to collaborate much more to achieve more. In KF, we can get involved in many more things than now. We believe KF and BR should remain separate groups.

Inputs

- What's stopping you?
- What could be improved?
- In the end, both BR, KF, and Hatten are here for the residents. Motoc presented that if any residents want to organize something involving Hatten, they should just contact Hatten.
- It would be nice if more tournaments were organized, especially focusing on sports – with prizes.
- **Input from BR:** The idea of forming workgroups focusing on specific areas.
- It would be nice to have the **beer pong** table back.
 - Refers to previous input about people just needing to contact the people working at Hatten.
- Mainly just an update on what KF and BR are working on.

Presentation of accounts for the period

- Salaries for KF board members will be removed.
- **Midsummer Festival:** There wasn't one, we only bought some trash bins.
- **Clubs:** Ceramics club spent some money.
- **Yoga:** Bought coffee and cake.
- **Volleyball:** Bought beer for those who participated in the tournament.
- **Hatten:**
- **LLO:** Removal of the subscription fee.

Inputs:

- Requirements for applying for funds for gatherings and activities.
- Guards at Hatten, why do we have them?
 - A few months before Motoc started here, someone got stabbed – we don't want that.
 - People often get drunk here – the guards are trained to handle that.
 - Some unfortunate incidents happened without guards.
 - The guards are well-trained! The customers here and the area are quite different from other student bars.
 - We want people to feel safe here, period.

Presentation of Hatten's accounts for the period

- The changed prices, how much will they affect the budget?
 - We spent everything we could to bring Hatten back to how it was before.
 - Most expenses from June and July will be part of next semester's budget.
- **Expenses:**
 - Most of them go towards stock.
- **Equipment:**
 - Most of the expenses were for the renovation of Hatten.
- **Administrative expenses:**
 - G4S was a problem from a former KF member, but we finally got rid of it.
 - Music system – Spotify and KODA.
 - Freelance: When there was a need for bartenders to keep the place open.

Inputs:

- Isn't it strange that the bar pays for the bartenders' food?
 - There is room in the budget to pay for food for those who work here. Most of them need to eat at some point because they have long shifts.
 - It's quite common for workplaces to make sure employees eat during work.
 - A suggestion to have an auditor to help keep an overview of the accounts.

The renovation of Hatten

- The administration, since they own the building, is responsible for ensuring the place adheres to regulations. However, many things had to be restored to how the place was left.

Approval of accounts

- Everyone voted in favor.

Presentation of next period's budget

- KF board members will no longer be paid.
- More money for Hatten.
- We don't expect to spend as much on the guards as we have allocated in the budget.

Vote: Everyone voted for the budget.

Residents' proposals / discussions

- A social club – a group focusing on the positives of social engagement.
 - Strong support from Hatten to organize this or collaborate on it.
- **Sauna:** There is no longer a sauna.
